About the CVMA

- The Canadian Veterinary Medical Association (CVMA) is the national and international voice for Canada's veterinarians, providing leadership and advocacy for veterinary medicine.
- The Canadian Veterinary Reserve (CVR) is a program of the CVMA.
- The CFIA provides contributions towards FAD emergency preparedness.



Establishment of the CVR

- March 27 & 28, 2006 : Inaugural workshop
- November 2006: announcement by the Minister of Agri-Food Canada and CVMA President
- November 2006: First CVR Advisory Board meeting
- January 2007: 300 applications received



Mandate of the CVR

The CVR provides veterinary surge capacity resources to first-responders in case of large-scale emergencies involving animals, in order to address animal health and welfare issues.




CVR Membership


- 474 Members with 245 of them having received formal training

CVR Target

- 1) Emergency preparedness and response for FAD
- 2) Emergency preparedness and response for domestic civil emergencies and non-reportable diseases
- Emergency preparedness and response for international civil emergencies (future)

Foreign Animal Disease (FAD)

- Recruitment
- Training / exercises
 - ICS
 - online orientation training modules
 - annual call-up training
 - Participate in exercise/training
- Deployment
 - on-the-ground training



2014-15 Avian Influenza Call-up, B.C.

- Overall, 11 commercial premises were infected and 245,600 affected birds had to be culled.
- 101 CVR members offered a total of 525 combined weeks of service.
- 70% offered 3 consecutive weeks of service between December 21, 2014 and March 1, 2015.



Civil Emergencies

- CVR support of provincial authorities
- CCVO has been part of the CVR Advisory Board since inception; CCEMO since 2013
- Provincial / CVR MOU
- CVR participation in provincial exercises
- On-line training for reservists





What would provinces use the CVR for?

Biological – epidemics (FAD, etc.) and vector (insect) infestations

Weather related — hurricanes, floods, storms, landslides, avalanches, fires, droughts, etc.

Geophysical – earthquakes, tsunamis, volcanic eruptions

Accidents — involving one or more transport trucks, trains, or planes carrying animals



What would be the role of the CVR members during a response?

- 1. Animal Search and Rescue
- 2. Identification & Tracking
- 3. Triage
- 4. Medical Care
- 5. Euthanasia
- 6. Evacuation (if required)
- 7. Recovery & Rehabilitation
