The original National Farmed Animal Health and Welfare Strategy (2009) was designed to provide strategic direction to farmed animal industry stakeholders to 2015. The renewed Strategy includes revisions to the strategic outcomes and identifies priorities to provide direction for stakeholders to 2020.

The most significant advancement for the 2020 Strategy is the engagement of all stakeholders in contributing to the measurement of progress on the strategic outcomes and sharing the responsibility to report on the achievements of those outcomes in their own words.

Dairy Farmers of Canada (DFC) is the national policy, lobbying and promotional organization representing Canada's farmers. DFC strives to create stable conditions for the Canadian dairy sector, today and in the future. 

SAFE FOOD

proAction is DFC's mandatory auditable quality assurance program designed to enable Canadian dairy farmers to collectively demonstrate responsible stewardship of their animals and the environment while producing sustainably high-quality, safe and nutritious food. The Food Safety module is based on the principles of HACCP.







ANIMAL WELFARE

DFC has submitted a letter of intent to NFACC to revise the Code of Practice. The Animal Care module of *proAction* is based on the requirements in the Code. The module became mandatory in September 2017 and is over halfway through the implementation process.

DFC and the Dairy Processors Association of Canada developed a National Third-Party Animal Audit Roster. The project developed and delivered a training course to chosen veterinarians so they can provide animal welfare audit services in the event of an incident or concern.

EMERGENCY MANAGEMENT

The Biosecurity module of *proAction* includes training materials for farmers and veterinarians. In September 2019, the requirements will be included in the audit process and will be implemented over a 2-year period. The Traceability module includes Premises ID, double-tagging, recording and reporting births, move-ins, and tag retirements. The module became mandatory in September 2017 and is over halfway through implementation.
