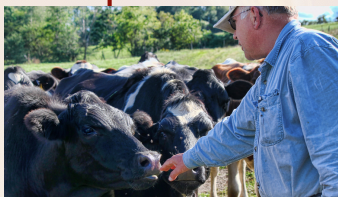

Forum 2022 Presenters

Dr. Mary Jane Ireland, CFIA

Dr. Mary Jane Ireland is the Executive Director of the Animal Health Directorate, Policy and Programs Branch at the Canadian Food Inspection Agency (CFIA). She is also the Chief Veterinary Officer (CVO) for Canada and the OIE Delegate for Canada.

Dr. Ireland graduated from the Ontario Veterinary College at the University of Guelph, with a degree in Veterinary Medicine and a post-graduate degrees in Veterinary Immunology and Business Administration. She began her career in a mixed animal practice in eastern Ontario.

In 2002, Dr. Ireland joined the Veterinary Drugs Directorate at Health Canada and held various positions, including Director General. In 2020, Dr. Ireland joined the Canadian Food Inspection Agency as the Executive Director of the Animal Health Directorate.

As the Chief Veterinary Officer, Dr. Ireland leads Canada's efforts to effectively manage current and emerging disease threats in order to protect animal health and human health, and to maintain international trust in Canada's inspection and certification systems in support of market access.

As the OIE Delegate, Dr. Ireland represents Canada on the international stage, and plays an integral role in Canada's participation in the OIE standard- setting process for the development and adoption of animal health standards and guidelines. In this role Dr. Ireland works to ensure that the standards are appropriately and consistently implemented in Canada. She is also responsible for notifying the OIE of reportable animal disease occurrences in Canada.



Hélène Trépanier, AHC Council Co-Chair

Dr. Hélène Trépanier has been Quebec's Chief Veterinary Officer since September 2016. She is one of three provincial and territorial representatives for Canada's Council of Chief Veterinary Officers on Animal Health Canada. Having worked for Quebec's Department of Agriculture, Fisheries and Food for over 30 years, Dr. Trépanier has been actively involved in the development and implementation of Quebec's animal health and welfare strategy. She is also an expert in the appropriate treatment of animals.

Dr. Trépanier holds a Doctor of Veterinary Medicine degree from the University of Montreal's Faculty of Veterinary Medicine (1984) and a Master's Degree in Veterinary Clinical Sciences from the same university (1987). She also has a Master's Degree in Rural Economy from Laval University in Quebec City (1995). She is currently a member of the Animal Welfare Committee of the Ordre des médecins vétérinaires du Québec. She joined the National Farmed Animal Health and Welfare Council, now Animal Health Canada, as a representative of the Council of Chief Veterinary Officers in March 2016.



René Roy, AHC Council Co-Chair

René Roy has a PhD in agricultural economics from McGill University. René is a pork producer from farrow to finish, a dairy farmer and a maple syrup producer. René took over the family business with his brother Mario and runs it with members of his family. René contributes with his experience on several working groups of the Council, in particular the One welfare working group. As an agricultural producer, he knows how the health and welfare of animals is intimately linked to the psychological health of producers.

René is second vice chair of the Canadian Pork Council, where he is active in the field of animal health and welfare. He has been particularly involved in the development of the new pork certification program, Canadian Pork Excellence. René contributes to the dialogue on hog health and welfare from a producer's perspective. He is also vice-chair of Swine Innovation Porc which is managing the research cluster of the Canadian pork industry. René represents the Canadian Pork Council on Animal Health Canada.

Jennifer Wright, CAHRC

Jennifer grew up working in her family's farm equipment dealership and helping on the farm in southwestern Ontario. She has worked in the field of human resource research and development for more than twenty years. Jennifer has worked with several industries, including agriculture, leading initiatives related to inclusion and diversity, attraction and retention, work integrated learning, labour market research, skills development, training and education. In addition to her work experience, she holds a Masters of Business Administration from Royal Roads University. Jennifer worked with the Canadian Agricultural Human Resource Council as a consultant for more than ten years before joining the staff in 2019 and is currently serving as the Acting Executive Director.



Jost am Rhyn, CVMA

Mr. am Rhyn graduated from business administration and economics in Switzerland. He has served for 37 years in CEO and Executive Director positions of national non-profit organizations in Switzerland and Canada; over 20 years were served as CEO of the Canadian Veterinary Medical Association and Registrar of its National Examining Board. Prior to his involvement in the non-profit sector, Mr. am Rhyn worked for a Swiss insurance company and, subsequently, with a multi-national enterprise in a position involved in business organization and restructuring. Mr. am Rhyn has served on the Boards of a number of organizations including, but not limited to, the Canadian Society of Association Executives (CSAE) and the Veterinary Medical Association Executives (VMAE).

Jackie obtained her Bachelor of Arts degree in Psychology from the University of Winnipeg, and a Master of Environmental Design from the University of Calgary.

Colleen McElwain, AHC Interim Executive Director

Colleen holds a Master of Science in Applied Behaviour and Welfare, and a Bachelor of Science in Animal Biology; both from the University of Guelph's Ontario Agricultural College. In 2020, she received her Certified Association Executive (CAE) professional designation. For over 15 years Colleen has worked within industry and government in various roles supporting animal health and welfare policy development and program implementation. As the Programs Director at Canadian Animal Health Institute, Colleen held a multi-functional role to provide organizational leadership in relation to communications, environmental stewardship programming, stakeholder relations and member service delivery. Prior to CAHI, she worked at the Ontario Ministry of Agriculture, Food and Rural Affairs (OMAFRA) leading her team on livestock traceability policy and stakeholder relations. For several years Colleen worked at the Turkey Farmers of Canada (TFC) where she was the lead for animal health and welfare, disease surveillance, traceability, antimicrobial resistance, and applied research policy and programming. She has participated on numerous national industry and government boards and committees, including a term as a Director at Large on the NFAHW Council Board representing the Canadian Animal Health Institute (CAHI).



Raphaël Bertinotti, EQSP Swine Endemic Disease Committee Coordinator

Raphaël is an engineer from the École nationale supérieure des sciences agronomiques de Bordeaux in France. He also holds an MBA from HEC Montreal and McGill University.

He worked for more than 17 years for Choice Genetics, a swine genetics company that is the merger of Pen Ar Lan, Newsham, and Monsanto Choice Genetics and that belongs to the second largest animal genetics group in the world, the Grimaud Group. He held the position of production manager for the Brazilian subsidiary for 4 years and then manager of the Canadian subsidiary, which was responsible for the North American market (mainly eastern Canada, Mexico and Dominican Republic) and served as a gene export platform for the South American market.



Since October 2015, he has been working for the Éleveurs de porcs du Québec where he oversees health, product quality (CQA then EPC), traceability and R&D. He sits on several boards of directors or management boards, including the board of directors of Swine Innovation Porc or the management board of the Chair in Meat Safety at the University of Montreal.

Since 2018, he has been the coordinator of endemic diseases and the antibiotic file for the Quebec pork industry through the EQSP.

Forum 2022 Panelists

Dave Taylor, DFC Director & AHC Director

Dave Taylor is the past Chair of the BC Dairy Association and a Director with Dairy Farmers of Canada. He is a passionate advocate for the BC and national dairy industry.

He and his brother operate Viewfield Farms in the Comox Valley on Vancouver Island, although the success of their farm lies with all who are a part of the Viewfield team which involves 3 generations.

The Taylors have been the recipients of the Top Quality Milk award for Vancouver Island for 8 of the last 10 years and have been in the top 5 herds for milk quality in the province each of the past 5 years. They are strong advocates of DFC's quality assurance program proAction.

In 2008, Dave and his wife Lisa represented their farm in competition in BC, and then nationally in Calgary, where they were awarded the Canadian Outstanding Young Farmers Award.

The Taylors have been dairy farming since Dave's grandfather bought his first farm in 1946 in Saanichton, just outside of Victoria, BC. They milk 130 registered holsteins.



Dr. Christina Lyn, Greenbelt Veterinary Services

Dr. Christina Lyn, DVM graduated from the Ontario Veterinary College in 2019 with a focus in large animal medicine. After graduation she moved to the Fraser Valley in British Columbia to work in a predominately dairy practice but sees everything from sheep and goats to pet pigs.

Graham Knox, BC Ministry of Agriculture and Food

Graham Knox is the Director of Emergency Management for the BC Ministry of Agriculture and Food. Graham has been involved in the field of emergency management for the past 3 decades in a variety of roles including First Aid, Ground and Urban Search and Rescue, Environmental Spill Response, Livestock and Poultry Disease Response, and Flood and Wildfire Response. Graham has served as a ground and urban search and rescue (SAR) team leader with Victoria and other provincial SAR teams, as a SAR instructor for the Justice Institute of BC, and in several roles with the BC Search and Rescue Association over a 16-year period. Graham served as the Director of the Environmental Emergency Program for the BC Ministry of Environment for 11 years, leading the province's planning and response for oil, hazardous materials, and other types of spills which included serving as the Provincial Incident Commander or Emergency Operations Center Director for numerous high-profile incidents. Since 2018 Graham has worked with the Ministry of Agriculture to lead the ministry's planning, preparedness and response for foreign animal diseases, wildfire, flooding, and other hazards that may impact the agriculture sector. This includes leading the provincial response to a Bovine Tuberculosis outbreak in 2018, the 2020 outbreak of Covid-19 at mink farms in the Fraser Valley and supporting the agriculture sector in numerous wildfire and flooding events. Graham's academic background includes a MA in Emergency and Disaster Management, and a BA in Geography, Political Science and Anthropology. When not busy with work and familial duties Graham can be found sea kayaking the BC coast, exploring the backcountry, or travelling the world with friends and family.
