Standards for Slaughter without Stunning

The National Farmed Animal Health and Welfare Council is pleased to make this document available to the public on behalf of the Canadian Council of Chief Veterinary Officers (CCVO).

It was developed by a federal-provincial-territorial working group under the guidance of the CCVO, to serve as a guide for the implementation of existing regulations. Its use is recommended to ensure clarity and to promote consistency in implementing humane slaughter regulatory requirements in each jurisdiction in Canada. The humane treatment of animals up to the time of death is a responsibility of all persons who may be involved.

The Council of Chief Veterinarians of Canada (CCVO), as the owners of the document, have undertaken to ensure that it remains relevant and up to date. However, implementation of this standard is the responsibility of officials within each respective jurisdiction in Canada. Should there be specific inquiries regarding implementation, questions may be addressed to the relevant authorities responsible. A general contact is also provided in some cases, should there be questions regarding other related topics.
