Antimicrobial Stewardship in Food Animals in Canada - 2016

Focus

Antimicrobial Stewardship

- Includes Infection Prevention and Control
- Recognizes the need for Surveillance and Innovation to be successful

Outcome

- Antimicrobial Stewardship in Food Animals in Canada published in 2016 is the reference document.
- Utilized in pan-Canadian AMR Framework development
- WG presented to the Stewardship Task Team
- Called to witness at the Commons' Standing Committee on Health – November 2017



AMU/AMR Next Steps

- Develop leadership role for Council on AMR
- Collectively advance AMR initiatives in collaboration with the commodity groups and veterinary groups
- Review, revise, emphasize and prioritize recommendations in Antimicrobial Stewardship in Food Animals in Canada



One Welfare



One Welfare

As a concept "One Welfare" is a call to recognize the many social interconnections between human welfare, animal welfare and the integrity of the environment. In practice, it is also a call for a coordinated program of action:

- to improve animal welfare in order to improve human welfare (and vice versa),
- to co-ordinate actions between animal protection and other services, and
- to protect the environment as a fundamental step for both human and animal welfare.



One Welfare

- Council interest and study began with participation in the International One Welfare Conference in Winnipeg in 2016
- Further study included:
 - Existing programs/projects in Canada
 - Some international activities
 - The needs of producers, farm staff, service providers and veterinary personnel in the agriculture community were considered
 - Non-exceptional operating conditions

Interim report on One Welfare is available on line and at registration



Key Factors Identified

- Open discussion on mental wellness in agriculture is required
- Local capacity for identification and response needs to be developed
- Existing services should be adapted to agriculture needs and integrated into response
- Further research and study is needed



Identified Actions

- Development of a cross-jurisdictional and multistakeholder leadership group to enhance communications, education, and support services
- Communication and education programs address the wellbeing of producers, farm staff, service providers and veterinary personnel working in agriculture
- Support of research and knowledge translation that is focused more specifically for agriculture
- Dialogue across all stakeholders in the agricultural industry to understand means of normalizing the importance of personal wellbeing



Emerging Issues



Potential project

Together with LMIS members responsible for humane destruction and disposal proposed a joint project to investigate with slaughter plants the key issues to be discussed to gain access to slaughter plants when:

- Mass humane destruction and disposal is required
- An emerging disease situation is disrupting market access



Animal Welfare



Management of Cull Dairy Cows

- Advisory statement with 19 recommendations
- Follow-up actions underway



Animal Welfare Law

- Summary of provincial, territorial and federal law
- Recommendations



National Animal Welfare System

- 2012 Advisory statement:
 - 22 recommendations
- Follow-up study by Jeffrey Spooner
- New strategy document planned for 2018

Progress since the last update

- All "2020" related activities reported during both pilot phases were organized according to the *Strategic Outcomes* and *5-Year Priorities* of the strategy
- An early concept for an eventual report was drafted and reviewed by the Working Group and Council



Goals for the FAHW 2020 reports

- Showcase an extensive range of reported activities
- Enable contributors to share and learn from one another
- Utilize an engaging format offering a variety of presentation styles
- Make reports concise, interactive, and highly accessible (e.g., convey 'good stories', provide links to more info, avoid jargon)
- Publish interim reports to stimulate successive contributions and reflect progress



General outline for the reports

- Organize according to "2020" priorities and strategic outcomes
- Include a general introduction per section (i.e., reflecting collective activities)
- Showcase unique/innovative activities and collectively representative examples
- Use a variety of presentation techniques:
 - Short articles plus Q & A's
 - Visuals (e.g., charts, diagrams, tables)
 - Bullet point lists featuring major achievements
 - Quotes from contributors






From policy to practice: a case example from the pig industry

Building blocks to One Health

- Spotlight on...
 - Development of research priorities that fall under the One Health umbrella
 - Environment and socio-economic Life Cycle Assessments
 - Sustainability roundtables
 - Veterinarian health and wellness resources







Next Steps

Plan and implement the next engagement process:

- Invite input on some (not all) priorities and outcomes at a time
- Avoid exceedingly broad/general questions
- Avoid questions likely to invite or require repeated contributions
- Encourage respondents to consider/include a wide range of activities

Concepts for future engagements

- Automate responses, wherever appropriate
- Display history of prior contributions enabling participants to simply update with new activities and achievements
